### MEUHP Board Approves COVID-19 Treatment Coverage with No Member Out-of-Pocket Costs

During their April 7 meeting, the MEUHP Board of Directors approved covering members claims who test positive <u>for COVID-19</u> to be processed by Cigna with NO out-of-pocket cost for member (waiving deductible, copays and co-insurance). This is in addition to MEUHP covering COVID-19 related testing and telehealth at no cost to the member.
