While the plan year changes on July 1, your deductible is on a calendar year. Any part of the deductible that you've met from January 1 through June 30 will apply toward the deductible for the remainder of the calendar year. For example, if you've met \$4,000 of your deductible and enroll in a \$5,000 deductible plan, you will only need to satisfy an additional \$1,000 from July 1 to December 31st. MEUHP's UNUM Life Insurance Update

For Districts who offer the MEUHP Unum Board Paid Life and Unum Voluntary Life Plans

Board Paid / Basic Life Insurance

There is one change to the Board Paid / Basic Life plan effective 7/1/2020. The Employee Life Insurance has NO



changes to the plan. However, if you covered your spouse and / or dependent children under the Board Paid / Basic plan, the dependent coverage only will end on 7/1/2020. The dependent coverage was \$5,000 for spouse and \$2,000 for children at a \$2.00 a month premium. However, you can cover your dependents under the Voluntary Life Plan as shown below.

Voluntary Life – Guaranteed Issue for 7/1/2020

The good news is you, your spouse and dependent children are **GUARANTEED ISSUE** coverage for voluntary term life insurance with this 7/1/2020 Open Enrollment.

- Employees can purchase up to \$200,000 (not to exceed 5 times salary)
- Your spouse can purchase up to \$50,000 (not to exceed the member's coverage)
- Children can be covered up to \$10,000 for \$2.00 a month (one premium covers all children.)

To find your premium on <u>ftjconnect.com</u>, just select the coverage amount you would like from the drop-down menu and your monthly premium will display. Premiums will increase as you reach a new age bracket.

This offer is "Forever Guaranteed Issue" This means if you purchase a minimum of \$10,000 at this open enrollment, you are guaranteed the ability to purchase insurance at future open enrollments – up to the Guaranteed Issue amount – regardless of any health condition you may have or develop.
